Meeting was called to order by Mayor Rhoads.

Invocation was given by Alderman Flynt.

A public hearing on application filed by BC Development; LLC, for the rezoning of +/- 2.82 acres on Mangum Drive (tax parcel F9I-5-10) was recessed at the last meeting and was to be continued at this board meeting. However, the applicant advised the City that it was withdrawing its application, and therefore no action was taken.

A motion was made by Alderman Rhoads to approve Change Order One to the contract with Thornton Construction Company, Inc. for a decrease in the amount of \$66,048.03 for the Liberty Park Improvements. This was seconded by Alderman Harmon and received unanimous approval from all Board Members present.

B. APPROVAL OF NUMBER SIX FINAL PAY REQUEST FOR THE LIBERTY PARK IMPROVEMENTS TO THORNTON CONSTRUCTION COMPANY, INC. IN THE AMOUNT OF \$50,350.93.

A motion was made by Alderman Rhoads to approve the Number Six Final Pay Request for the Liberty Park Improvements to Thornton Construction Company, Inc. in the amount of \$50,350.93. This was seconded by Alderman Smith and received unanimous approval from all Board Members present.

C. APPROVAL OF CHANGE ORDER THREE (FINAL) TO THE CONTRACT WITH DELTA CONSTRUCTORS, INC. FOR A DECREASE IN THE AMOUNT OF \$135,430.77 FOR THE HOGG CREEK INTERCEPTOR EXTENSION PHASE V, PART 2.

A motion was made by Alderman Harmon to approve Change Order Three (final) to the contract with Delta Constructors, Inc. for a decrease in the amount of \$135,430.77 for the Hogg Creek Interceptor Extension Phase V, Part 2. This was seconded by Alderman Smith and received unanimous approval from all Board Members present.

D. APPROVAL OF NUMBER 18 FINAL PAY REQUEST FOR THE HOGG CREEK

INTERCEPTOR EXTENSION PHASE V, PART 2 IN THE AMOUNT OF \$5,556.70.

A motion was made by Alderman Harmon to approve the Addendum to approve Number 18 Final Pay Request for the Hogg Creek Interceptor Extension Phase V, Part 2 in the amount of \$5,556.70. This was seconded by Alderman Smith and received unanimous approval from all Board Members present.

E. DECLARATION OF AN EMERGENCY REPAIR TO THE NORANCO WATER WELL #2 Garry Miller, public works director, reported that the Noranco Water Well #2 has been losing pumping capacity and has been taken offline while an inspection was performed by Grinder Drilling Service, Inc. The inspection revealed that in order to return this well to service there were immediate repairs that would need to be done, including a complete well cleaning for a total estimated cost of approximately \$70,000.00. Mr. Miller further reported that while this well is offline, and emergency exists necessitating immediate action and the delay incident to giving opportunity for competitive bidding would be detrimental to the interest of the City.

A motion was made by Alderman Smith to authorize emergency repairs to the Noranco Water Well #2 and to authorize the Mayor to execute a Work Order/Contract with Grinder Drilling Service, Inc., for the immediate repair. This was seconded by Alderman Rhoads and received unanimous approval from all Board Members present.
