

CITY OF FLOWOOD REGULAR MEETING OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF FLOWOOD, RANKIN COUNTY, MISSISSIPPI HELD August 7, 2017 6:30PM

BE IT REMEMBERED THAT THE Board of Aldermen of the City of Flowood met at their regular meeting place on August 7, 2017 at 6:30 P.M., when and where the following were present to wit:

Alderman Deron Harmon, Alderman (Mayor Pro Tem) Don Flynt, Alderman Kathy Smith, Alderman Kirk McDaniel and Joshua Carlisle, City Clerk. Alderman Dusty Rhoads was absent.

OTHERS PRESENT: Lem Adams, III, Garry Miller, Chief of Police Richie McCluskey, Johnny Dewitt, Fire Chief Jeffrey Welborn, Greg Wilcox, Chris Bowers, Mason Nichols, and Michael Nichols.

The Meeting was called to order by Mayor Pro Tem Don Flynt.

The invocation was given by Alderman McDaniel.

Mayor Pro Tem recognized Mason Nichols, a Boy Scout who is working on a Merit Badge.

Item # 1 - PUBLIC HEARING ON THE INTENT TO EITHER ISSUE GENERAL OBLIGATION BONDS OF THE CITY OF FLOWOOD, MISSISSIPPI OR ISSUE A GENERAL OBLIGATION BOND OF SAID CITY FOR SALE TO THE MISSISSIPPI DEVELOPMENT BANK, IN ONE OR MORE SERIES, ALL IN AN AGGREGATE PRINCIPAL AMOUNT OF NOT TO EXCEED FIVE MILLION DOLLARS.

The Mayor Pro Tem opened a public hearing on the above matter and asked for those desiring to speak for or against the Application to speak. No one appeared to protest.

A motion was made by Alderman McDaniel to approve the RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF FLOWOOD, MISSISSIPPI FINDING AND DETERMINING THAT THE NOTICE OF RESOLUTION OF INTENT TO either ISSUE GENERAL OBLIGATION BONDS OF THE CITY OF FLOWOOD, MISSISSIPPI IN AN AGGREGATE PRINCIPAL AMOUNT OF NOT TO EXCEED FIVE MILLION DOLLARS (\$5,000,000), WAS DULY PUBLISHED AS REQUIRED BY LAW AND THAT NO WRITTEN PROTEST OR OTHER OBJECTION OF ANY KIND OR CHARACTER AGAINST THE ISSUANCE OF SUCH GENERAL OBLIGATION BONDS, OR THE USE OF THE PROCEEDS THEREOF, HAS BEEN FILED BY QUALIFIED ELECTORS OF SAID CITY; DECLARING THE NECESSITY FOR THE SALE AND ISSUANCE OF SUCH GENERAL OBLIGATION BONDS AND FOR RELATED PURPOSES (copy attached). This motion was seconded by Alderman Harmon and received unanimous approval from all Board Members present.

- J. Authorization for the Mayor to sign the Bidding Agent Agreement for Raymond James to serve as bidding agent on the escrow bid in conjunction with the refunding.

Item #1 - PUBLIC HEARING ON AN APPLICATION FILED BY CITY OF FLOWOOD FOR REZONING FROM L-C TO C-3 FOR THE PARCEL DESCRIBED NW 1/4 OF THE SOUTHEAST QUARTER (SE 1/4) OF SECTION 33 T6N R2E, CITY OF FLOWOOD, RANKIN COUNTY, MISSSISSIPPI, FLOWOOD, MISSISSIPPI 39232.

The Mayor opened a public hearing on the above matter and asked for those desiring to speak for or against the Application to speak. Mike Prestage explained the purpose of the application and the need for rezoning.

A motion was made by Alderman McDaniel to approve the Application for Rezoning from L-C to C-3 for the Parcel Described NW ¼ of the Southeast Quarter (SE ¼) of Section 33, T6N, R2E, City of Flowood, Rankin County, Mississippi, Flowood, Mississippi 39232 and approve the Ordinance Rezoning said property (copy attached). This motion was seconded by Alderman Harmon and received unanimous approval from all Board Members present.
