BE IT REMEMBERED that the Mayor and Board of Aldermen of the City of Flowood met at their regular meeting place on August 1, 2022, at 6:30 P.M.

The Meeting was called to order by Mayor Rhoads.

The invocation was given Alderman Harmon.

Item #1 – Public hearing on the adoption of an ordinance of the City of Flowood, Mississippi prohibiting the use, purchase, possession, distribution, sale or offering for sale, of synthetic cocaine or other synthetic products often referred to as Kratom

Alderman Harmon exited the meeting.

The required notice (copy attached) having been given, the Mayor opened the public hearing on the above matter and asked for those desiring to speak for or against adoption of the ordinance (copy attached) to speak. Police Chief Ricky McMillian, as well as Mississippi Bureau of Narcotics employees Leigh Cochran and Will Peterson were present and spoke in favor of the ordinance being adopted. Alderman Robbins questioned the scope of the ordinance and noted the failure to ban kratom at the state and federal level. No one was present to speak against adoption of the ordinance. After questions from Board members, the Mayor closed the public hearing.

A motion was made by Alderman McDaniel to adopt the ordinance. This motion was seconded by Alderman Smith and received a majority approval from all Board Members present with Alderman Robbins voting against adoption of the ordinance.
