BE IT REMEMBERED that the Mayor and Board of Aldermen of the City of Flowood met at their regular meeting place on December 7, 2020 at 6:30 P.M.

The Meeting was called to order by Mayor Rhoads.

Item #1 – Public Hearing on an application filed by Seafood Flowood, Inc. d/b/a The Juicy Seafood located ta 111 Market Street to be designated as a Special Resort Status for the sale of alcoholic beverages
