REGULAR MEETING OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF FLOWOOD, RANKIN COUNTY, MISSISSIPPI Held December 2, 2024

BE IT REMEMBERED that the Mayor and Board of Aldermen of the City of Flowood met at their regular meeting place on December 2, 2024, at 6:30 P.M.

The following members were present: Mayor Gary Rhoads, Alderman Deron Harmon, Alderman Kathy Smith, Alderman Seth Robbins, Alderman Kirk McDaniel, and City Clerk Josh Carlisle.

The Meeting was called to order by Mayor Rhoads.

The invocation was given by Pastor Bobby McGuffie.

Item #1 – Public Hearing on an application filed by Amigos Mexican Restaurant Flowood located at 630 Grants Ferry Road, Unit 5293 to be designated as a Special Resort Status for the sale of alcoholic beverages

The required application and notices having been filed and given (copies attached), the Mayor opened the public hearing on the above matter and asked for those desiring to speak for or against the application to speak. Damian Roman was present stating that he read and understood the ordinance and spoke in favor of the application being granted. The Mayor closed the public hearing.
