Item #1 – Public hearing to consider whether to amend paragraph 307.02-04 of the City of Flowood Zoning Ordinance by deleting the words "apartment residences" and to repeal all ordinances in conflict therewith – Rusty Fortenberry

Rusty Fortenberry presented the proposed ordinance amending paragraph 307.02-04 of the City of Flowood Zoning Ordinance (copy attached). The required notice of public hearing having been published; the Mayor opened the public hearing. Mayor Rhoads and Alderman McDaniel stated that there was a mistake in paragraph 307.02-04 of the Flowood Zoning Ordinance when adopted by inclusion of "apartment residences." The City of Flowood, Mississippi Comprehensive Plan of October 2011 also does not contemplate "apartment residences" in C-2 Restricted Commercial Districts. The Mayor asked if anyone desired to speak against the proposed ordinance. No one else spoke in favor of or against the proposed ordinance. The Mayor closed the public hearing.

A motion was made by Alderman McDaniel to adopt the ordinance amending paragraph 307.02-04 of the City of Flowood Zoning Ordinance to remove the words "apartment residences." The motion was seconded by Alderman Smith. After a roll call vote, the motion received unanimous approval from all Board members present.
