BE IT REMEMBERED that the Mayor and Board of Aldermen of the City of Flowood met at their regular meeting place on November 5, 2018 at 6:30 P.M., when and where the following were present to wit:

The Meeting was called to order by Mayor Rhoads.

The invocation was given by Alderman Harmon.

Item #1 – Public Hearing for consideration of an Ordinance adopting regulations for small cell technology facilities in the City of Flowood, Mississippi

A public hearing was held for consideration of an Ordinance adopting regulations for small cell technology facilities in the City of Flowood, Mississippi (copy attached). It was confirmed that the prerequisites for the notice of the public hearing had been satisfied. The Mayor opened the hearing. City Attorney, Rusty Fortenberry, presented the Ordinance and recommended adoption of the Ordinance. No one else addressed the Board regarding the Ordinance. The Mayor closed the public hearing.
