# Item #1 – Public Hearing on an application filed by Zhui Zheng d/b/a Mighty Crab Flowood, LLC located at 109 Market Place Lane to be designated as a special resort status for the sale of alcoholic beverages

The required application and notices having been filed and given (copies attached), the Mayor opened a public hearing on the above matter and asked for those desiring to speak for or against the Application to speak.
